**IFA Aquaculture will hold a major conference on the future of aquaculture and seafood policy in Ireland and the EU on 3<sup>rd</sup> & 4<sup>th</sup> April 2007 in the Marriott Johnstown House Hotel, Enfield, Co Meath.**

“Aqua 20/20” refers to both the year which we have picked to try and predict future options for the seafood sector and also the clear “20-20” vision necessary to deliver on a range of challenges – business, marketing, environmental and regulatory.

The aim of the event is to put the current state of fishing and aquaculture at a global, EU and local scale in context.

Aqua 20-20 will look at the challenges of production. R&D and communications facing operators, state agencies, Government and the EU and look forward to the implementation of policies to develop the Seafood sector to the year 2020.

The goal of Aqua 20-20 is to establish a range of priorities and targets for the sector, looking at the plans currently being set for the next seven years in national and EU policies and the likely scenarios for industry to deliver supply to an increasing demand for seafood in the European Community and beyond.

### **3<sup>rd</sup> April 2007 – Day 1:**

Will see the main conference and trade show with many special events and speakers, including regulators, politicians and analysts at national, EU and global level. The Conference will look at current issues with Fisheries, Aquaculture and Processing in Ireland while speakers will examine the soon to be launched NDP for Fisheries, R&D priorities for the sector, EU issues and development goals.

### **4<sup>th</sup> April 2007 – Day 2:**

Will kick off with a special business breakfast with a well-known personality and see special workshops for the finfish and shellfish aquaculture industries on practical topics of interest to IFA Aquaculture members. Day 2 will also see the Annual General Meetings held of both the ISGA and the ISA under one roof.

Aqua 20-20 is aimed at the **seafood and aquaculture industry, regulators, fish processors and marketers, the business community and policy makers**. The event will also comprise a **trade show** and a **seafood cookery marketing/communications presentation** by a well-known chef.
